[PROPOSED] JUDGMENT

14 Pursuant to the Order Granting Final Approval of Class Action Settlement (“Final Approval
15 Order”) and Order Granting Plaintiffs’ Motion for (1) Award of Attorneys’ Fees, (2) Reimbursement
16 of Costs and Expenses, and (3) Service Awards (“Fees Order”), it is hereby ORDERED,
17 ADJUDGED, AND DECREED as follows:

18 1. Judgment in this matter is entered in accordance with, and incorporates by reference
19 the findings and holdings of, the Final Approval Order, Fees Order, and the Parties’ Class Action
20 Settlement Agreement (“Settlement Agreement”) (Dkt. No. 365-1).

21 2. Capitalized terms not defined herein shall have the meanings set forth in the
22 Settlement Agreement.

23 3. The Court adjudges that upon the Effective Date, Plaintiffs and the Settlement Class
24 Members—except those listed on Exhibit A hereto—have released, forever discharged, and will not
25 in any manner pursue this Action, and will be forever barred from asserting, instituting, or
26 maintaining against the Releasees, any and all Released Claims (as defined by the Settlement
27 Agreement, § 1.34).

28 4. Without affecting the finality of this Judgment in any way, the Court shall retain
continuing jurisdiction of all matters relating to the interpretation, administration, implementation,
and enforcement of the Settlement Agreement.
